



## **The Āti Awa Toa Wellington Regional Sports Awards 2025 Terms and Conditions**

Each individual or organisation (on behalf of their registered individuals) who purchases tickets for the Wellington Regional Sports Awards 2024 agrees to be bound by these terms and conditions:

### **1. Payment Terms**

All tables and seats are reserved on a first-come-first-served basis. Full payment must be made within seven (7) working days upon invoice date. Seats will only be reserved upon receipt of payment. A confirmation email and invoice will be sent within 5 working days upon bookings being made through the event website. Nuku Ora reserves the right to rescind any booking if payment is not received in full after 7 days of invoice date.

### **2. Substitutions**

Once a booking has been made, substitutions are permitted without additional costs. Substitutions and dietary requirements must be communicated in writing at least 14 days prior to the event. No refunds will be issued to ticket holders that are no longer able to attend.

### **3. Cancellation**

Nuku Ora reserves the right to cancel the event for any reason.

If Nuku Ora is forced to cancel the event, an 85% refund will be made for all bookings if cancellation is up to 14 days prior to the event date of 28 August 2025. Refunds will be processed within 20 working days. Any cancellation within 14 days of the event date of 28 August 2025 no refunds will be made.

### **4. Personal Information Consent**

Nuku Ora and Āti Awa Toa FM, as organisers of the event are committed to respecting your privacy and ensuring the security of any personal information you provide to them. You acknowledge that any personal information you provide to Nuku Ora and Āti Awa Toa FM via this registration or otherwise, will be processed in accordance with their Privacy Policies and all applicable privacy laws, including the Privacy Act 2020 (NZ) (Privacy Act) and the sections below. Please refer to Nuku Ora and Āti Awa Toa FM's Privacy Policies for further details. These are available on request.

I understand I have the right of access to such information, and to correct it by applying in writing to the Privacy Officer, Nuku Ora, Level 1, 223 Thorndon Quay, Wellington. These rights are subject to certain limitations and exceptions as set out in the Privacy Act.
